- 1. Course Provisions:** Alert Driving School, Inc. will provide a minimum of 6 hours of classroom instruction provided by a certified instructor. The required score to pass the STATE TEST is 70%; the student will have two attempts to pass the test.
 - 2. Verification:** A minimum of 30 hours of supervised driving, including two hours minimum of nighttime driving, on a Level 1 license that has been held for at least three continuous months must be completed before a student can be accepted into Segment 2. Supervised driving is defined as driving with a licensed parent, guardian or parent designee age 21 or older
 - 3. The Fee for the Course:** \$85.00, which is due and payable at the time of submitting this contract. Payment may be made by cash, check or money order. There is a fee of \$40.00 for any NSF or "Stopped Payment" check.
 - 4. Refund Policy:** A full refund, less a \$25 registration fee for cancellations up to 1 week prior to the 1st class. No refunds made if a cancellation is made later than 1 week prior to the 1st class.
 - 5. Missed Class:** If a student misses a scheduled class, he or she immediately fails the course and forfeits their fee.

Before taking a road test you must

1. Complete **Segment One** and **Segment Two** of Driving Education.
2. Practice 50 hours on the road (10 hours at night).
3. You **MUST** present your Driving Log, with all hours accounted for.
4. Possess a Level One License for a minimum of 6 months.
5. Not have received a ticket or been in an at-fault accident for previous 90 days.

Day of test, bring with you

1. Level One license (aka: Driving Permit – **MUST BE LEGIBLE** and **NO COPIES**)
2. Proof of Insurance - **CURRENT**
3. Proof of Registration - **CURRENT**
4. White Segment Two Certificate of Completion
5. Parent or Legal Guardian must accompany you to the test site.
6. Your GDL Log Book showing the minimum 50 hours on the road (10 hours at night).
